What is ARES?

The Amateur Radio Emergency Service[®] (ARES) consists of licensed amateurs who have voluntarily registered their qualifications and equipment, with their local ARES leadership, for communications duty in the public service when disaster strikes. ARES is the emergency arm of the ARRL.

What is RACES?

Radio Amateur Civil Emergency Service (RACES) is a part of Amateur Radio Service that provides radio communications for civil-preparedness purposes only, during periods of local, regional or national civil emergencies. Their emergencies are not limited to war-related activities, but can include natural disasters such as fires, floods, and earthquakes. RACES is administered by local/county/state emergency management agencies.

How Do They Differ?

- RACES is government (City, County) administered.
- RACES serves the government agency
- RACES is limited on their drills
- ARES is ARRL administered
- ARES serves a variety of agencies
- ARES is unlimited in drills

How Do I Join?

The possession of emergency-powered equipment is desirable, but is not a requirement for membership.
