Miscellaneous Radio

SOTA

It often amazes me what hams will come up with to provide new and interesting ways to enjoy the hobby. The Islands On The Air [IOTA] program was created by the RSGB a number of years ago and is very popular [www.rsgbiota.org/info/index.php] The basic concept was that islands would be registered and given an IOTA number ... a two-character alphabetic designator identifying the continental area, and a three digit serial number. There are some rules as to what constitutes an "island," such as it has to be in open sea [Angel Island and Alcatraz are not IOTA islands since they're inside SF Bay, however the Farallon Islands are NA-178 since they're in the Pacific].



You obtain points in the program – that would be “programme” since it’s British – by either working islands, or putting islands on the air. Rick, K6VVA [the big guy on the right], a member of the No. Cal. Contest Club, and Mike, K9AJ, activated NA-178 several years ago. The Farallons are a wildlife refuge owned by the Federal Fish and Wildlife Service, and administered by a non-profit wildlife foundation. It took Rick a couple of years with major help from his Congressman to finally get permission to travel there and operate for 3 days, and the entire expedition was a huge undertaking.

They had to take their antennas down at night lest some endangered late night bird crash into them. At Rick’s presentation to the contest club, the most prevalent bird species in the photos was seagull which none of us knew was endangered [been to a landfill lately?], but we’ll take the Farallon Keeper’s word for it.

In the IOTA program, the Farallons were in the top ten of wanted islands worldwide, having last been activated in the early 90’s. And, it was only because once Rick decides to do something, he never gives up that they did finally

manage to get them on the air. The only access to the islands is either by sea or helicopter, and the marine access is hazardous and unsuitable for hams and their gear, so they flew. Helicopters are notoriously poor at lifting large payloads, so Rick and Mike had to balance the “What do we really need” with “What can we leave at home so this aircraft can actually take off.”

What does this have to do with SOTA? Well, as Rick found out, getting to islands can be a difficult, long, and costly task. So, again in the UK, a separate programme has been launched [Mar 2002] -- “Summits On The Air” -- and it is catching on rapidly in Europe. Summits do not generally require a boat although a helicopter might be useful for some, you are permitted to drive to the summit [although operation from a vehicle is not allowed], and the rules [www.sota.org.uk] make allowances for situations where operation from the exact summit point is not physically possible. In the W6 SOTA Association, that allowance is 80 vertical feet.

A major rule for summit qualification is what they call “prominence.” Roughly speaking, this is the distance the summit sticks up above surrounding terrain, although the precise definition is much more complex. Years ago, I heard this property of a mountain called “tallness,” but prominence seems to be the accepted term now. A summit must have a prominence of 500 ft to qualify in the W6 SOTA Association.

California has been divided into several groups and a number of summits identified already. You will recognize many, they’re the ones along the Pacific Crest Trail, and were chosen from an atlas [www.peaklist.org/CAMtnatlas/CAMtnatlas.htm]. We are in the Whitney Group, Pyramid Cell in the atlas. It turns out that prominence is a major player in orometry, the study and classification of terrain features which is closely related to topology, the mathematics of surfaces. It also turns out that



ometry is a much more complex subject than I ever thought it would be. There’s a section on Orometric Theory on the peaklist site if you’re interested.

I've been to the summit of Mt. Whitney as a teenager [no radio, they were fairly big and heavy then] and there is no doubt left that I won't be returning. However, there are a number of accessible summits around us here in the Sierra. The first one I checked was Bald Mtn east of Georgetown which is the home of two of the VHF and UHF repeaters used on the WSER and Tevis each year. There is a dirt road to the top, and the atlas lists its prominence at 512 ft, just over the SOTA minimum. If I can get the W6 Association manager to add Bald to the W6 SOTA list and give it a designator, I might do the Flight of the Bumblebees contest from there next July with my K2 and Buddipole. I have been doing them from Overlook Park in Auburn, but I'm getting a little tired of the same place each year.

So, if you are already at the top of the DXCC Honor Roll and have your walls covered with winning certificates, SOTA might just be the ticket for you. Many summits around us can be accessed for the cost of gasoline to get there, and radios and batteries are small and light enough now to make backpacking possible. There is a SOTAalert section on the UK website where you can post your summit activation plans and read about others.

And, here's a quick puzzle: Anyone who has driven up I-5, come around the corner and seen Mt. Shasta just sticking up from the valley floor has an appreciation for the concept of "tallness" or prominence. Mt. Whitney is the highest point in the lower 48, however it is surrounded by many peaks almost as high, and looking at the crest of the Sierra, it is hard to actually pick it out. This is also true of Mt. Everest, but not a problem with Shasta! So, if "tallness" means the "vertical distance from the peak to the lowest surrounding parts of the earth's surface," what is the tallest mountain on the planet? Answer next month.
